Disability Royal Commission

The Disability Royal Commission was established in April 2019 in response to community concern about widespread reports of violence against, and the neglect, abuse and exploitation of people with a disability. These incidents might have happened recently or a long time ago.

The Disability Royal Commission will achieve this by preventing and better protecting people with a disability from experiencing the following: violence, abuse, neglect and exploitation. Achieving best practice in reporting, investigating and responding as well as promoting a more inclusive society that supports people with a disability to be independent and live free from violence, abuse, neglect and exploitation.

The Disability Royal Commission will investigate and report on experiences and conditions in all settings and contexts, including: Schools, workplaces, jails, group homes or boarding houses, family homes, hospital and day programs




The Disability Royal Commission gathers information through research, public hearings, personal experiences as told by community, private sessions, and other forums. We will deliver a final report to the Australian Government by 29 April 2022. In this report, the Royal Commission will recommend how to improve laws, policies, structures and practices to ensure a more inclusive and just society.

KNOW YOUR RIGHTS

What is Breach of Bail?

Breach is "an act of breaking or failing to observe a law, agreement, or code of conduct"

Bail

Applications for bail in all courts are generally governed by the <u>Bail Act 1985</u> (SA), which applies to both South Australian and Commonwealth offences.



What is bail?

A person who is in <u>custody</u> because he or she has been charged with an offence or is involved in pending criminal proceedings, may apply to be released on bail. Normally in signing a bail agreement a person undertakes the following:

- To be present every time the matter is in court until the proceedings are finished.
- To comply with any conditions set out in the agreement as to conduct while on bail.
- To forfeit a specified sum of money if the person fails, without proper excuse, to comply with any term or condition of the agreement.






KNOW YOUR RIGHTS

A bail authority may further impose the following conditions on a bail agreement:


- reside at a specified address;
- home detention;
- conditions relating to the physical protection of a victim;
- supervision by a community corrections officer;
- report to police;
- surrender of any passport;
- the applicant provides written assurances from acquaintances that the applicant will comply with the conditions of bail;
- forfeiture of a specified sum of money if the applicant fails, without proper excuse, to comply with any term of the agreement;
- the applicant lodges with the court security of a specified amount or value, to secure payment of the money stipulated in the bail agreement;
- the applicant obtains specified guarantors of a special nature; and that the guarantor lodges with the court security of a specified amount or value to secure payment of the money stipulated in the guarantee agreement.



SCAMS

We are all vulnerable to these scams. Talk to ALRM who offer support or talk to people whom you trust about what happened. Scams rely on fear base threats, and victims continue to live with the emotional impact and financial loss. Be gentle with yourself and reach out for support.



- STOP, Take TIME to think through.
- Hang up phone, close internet browser.
- If sounds too good to be true, then probably is.
- Do not feel pressured to provide personal or banking information.
- Be SUSPICIOUS of requests of money-even if sound or look official.
- Do your own research on callers details.
- · Check bank statements regularly.
- Check with your Bank provider on their Cybersecurity/fraud policy and procedures.
- Big 4 banks offer 24 hour cybersecurity monitoring.

I am enjoying myself so far and look forward to whatever comes my way next!




Hello everyone! My name is Nesrin, I was born in Croatia and came over to Australia in 2002. I am the eldest daughter to Middle Eastern and European parents.

South Australian Aboriginal Community Controlled Organisation Network (SAACCON)

History is Made! Signing of National Agreement on Closing the Gap . Ruth Miller is the Lead Convenor for South Australian Aboriginal Community Controlled Organisation Network (SAACCON). SAACCON is a member of the Coalition of Aboriginal and Torres Strait Islander Peak Organisations (Coalition of Peaks). Government processes for Closing the Gap have not been working and the Coalition of Peaks came together out of frustration with previous processes. The Coalition of Peaks requested participation in the Australian Governments refresh of Closing the Gap; as equal partners in the development of the new National Agreement for Closing the Gap. This Agreement is historic as it is the first time a National Agreement about the First Nations people has been negotiated in partnership with the First Nations people in Australia.

The **4 Priory Reform** areas are key enablers to drive institutional reforms such as requiring mainstream services to provide culturally safe services and to meet the needs of Australia's Aboriginal and Torres Strait Islander people:

- 1. Shared decision-making: Aboriginal and Torres Strait Islander people are empowered to share decision-making authority with governments to accelerate policy and place-based progress on Closing the Gap through formal partnership arrangements.
- 2. Building the community-controlled sector: There is a strong and sustainable Aboriginal and Torres Strait Islander community-controlled sector delivering high quality services to meet the needs of Aboriginal and Torres Strait Islander people across the country.
- **3. Improving mainstream institutions:** Governments, their organisations and their institutions are accountable for Closing the Gap and are culturally safe and responsive to the needs of Aboriginal and Torres Strait Islander people, including through the services they fund.
- **4. Aboriginal and Torres Strait Islander-led data:** Aboriginal and Torres Strait Islander people have access to, and the capability to use, locally-relevant data and information to set and monitor the implementation of efforts to close the gap, their priorities and drive their own development.



Aboriginal Visitors Scheme (AVS)

AVS Visitors Vacancies

The aim of the Aboriginal Visitors Scheme (AVS) is to provide all Aboriginal and Torres Strait Islander people with after-hours comfort, care and support when arrested and detained in police custody. AVS Visitors assist SAPOL in their duty of care, and help bridge communication between each. AVS Visitors are available across the state.

The AVS was established as a result of the Royal Commission into Aboriginal Deaths in Custody recommendations (1991). 'In consultation with Aboriginal Communities and their organisations, cell visitor schemes (or schemes serving similar purpose) should be introduced to service Police watch houses.'

AVS Visitor Role and Functions

- Have a yarn
- Make referrals to other agencies
- Be an advocate
- Provide counselling
- · Contact family if needed

Visitor Essential Requirements:

- To be available between 5pm and 9am weekdays, and weekends and public holidays
- Confident, empathetic people person, with great listening skills
- Must be 18 years or older
- Willing to work after hours
- Knowledge of local Aboriginal community, and community health services
- Respond to police call outs to attend at local police holding cells
- Current Drivers Licence (Own transport required)
- Mobile phone
